AND WHEREAS all that piece and parcel of the property lying being and situated at village Charholi Budruk, Taluka Haveli, District Pune being Survey No. 134, admeasuring 3 Hectare 95 Ares Akar Rs.7=50 Paise which is within the jurisdiction of Registrar of Assurances, Pune and within the local limits of Pimpri-Chinchwad Municipal Corporation is owned and possessed by Dr. D.Y.
