A.01- NAME

The name of the Society shall be Padmashree Dr D Y Patil Vidyapeeth (Institution Deemed to be University), hereafter referred to as "THE INSTITUTION DEEMED TO BE UNIVERSITY"

A.02- OFFICE

The Registered office of the University shall be situated at D Y Patil Vidyagar, Sector 7, Nerul, Navi Mumbai 400-706F

A.03- OBJECTIVES OF AN INSTITUTION DEEMED TO BE UNIVERSITY

The objectives for which an institution is declared by the Government as an Institution Deemed to be University shall be:

- 3.1 To provide for higher education leading to excellence and innovations in such branches of knowledge as may be deemed fit primarily at post-graduate and research degree levels fully conforming to the concept of University, namely, University Education Report (1948) and the Report of the Committee on Renovation and Rejuvenation of Higher Education in India (2009) and the Report of the Review Committee for Deemed to be Universities (2009).
- 3.2 To engage in areas of specialization with proven ability to make distinctive contributions to the objectives of the University education system that is academic engagement clearly distinguishable from programmes of an ordinary nature that lead to conventional degrees in arts, science, engineering, medicine, dental, pharmacy, management, etc. routinely offered by conventional institutions.
- 3.3 To provide for high quality teaching and research and for the advancement of knowledge and its dissemination through various research programmes undertaken in-house by substantial number of full time faculty / research scholars (PhDs and Post Doctoral) in diverse disciplines.



A.04- POWERS AND FUNCTIONS OF THE INSTITUTION DEEMED TO BE UNIVERSITY

To carry out the above objectives and of the management and properties of the Institution Deemed to be University and shall have the following Powers and functions:-

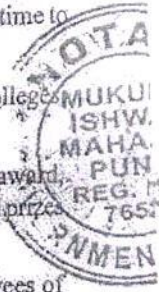

- i) to establish, maintain and manage constituent colleges, departments, laboratories, museum and equipments for teaching or research in modern medicine;
- ii) to establish, maintain and manage departments and schools of research and specialized studies;
- iii) to organize, maintain and manage hostels, health center, auditorium and gymnasium;
- iv) to create post (s) of Dean, Principal, Teachers and other teaching or non-vocational academic posts with the prior approval of the Institution Deemed to be University and to prescribe their qualifications and make appointments thereto;

- vi) to create non-teaching administrative and technical post (s) and prescribe their qualifications and pay scales with prior approval of the sponsoring and to make appointments thereto;
- vii) to control and regulate admissions of students for various undergraduate and post-graduate courses of study in the Institution Deemed to be University as per the norms prescribed by the University Grants Commission, from time to time;
- viii) to monitor and evaluate the academic performance of the constituent colleges, departments and hospital and their periodical accreditation;
- ix) to hold and manage properties and endowments and institute and award fellowships, travelling fellowships, scholarships, studentship, medals and prizes for teachers and students.
- x) to make arrangements for promoting welfare of students and employees of the Institution Deemed to be University;
- xi) to provide for training and quality improvement of teachers and non-teaching employees;
- xii) to provide for periodical assessment of the performance of teachers and non-teaching employees of the Institution Deemed to be University in accordance with the provisions made in the Rules;
- xiii) to regulate and provide for attendance of the teachers on the premises of the Institution Deemed to be University during teaching hours and beyond teaching hours as prescribed by the University Grants Commission, from time to time;

- xiv) to prohibit teachers from taking or conducting private tuition or private coaching classes;
- xv) to establish, manage and maintain whenever necessary:
  - (a) Printing and Publication Department
  - (b) Extension Board
  - (c) Computer Centre
  - (d) Health Centers and Public Health Centers
- xvi) to co-operate or collaborate with any other universities, institutions or organization for research, extension and advisory services and for such purposes to enter into appropriate arrangement with other universities, institutions or organizations to conduct certain courses as the situation may demand;
- xvii) to explore the possibilities of augmenting the resources of the Institution Deemed to be University by exploring or innovating such as research and development, consultancy, training programmes and provide services of different clients from the pharmaceutical and other industries or any other non-governmental organization;
- xviii) to receive funds for collaboration programmes from international agencies both from within the country and outside the country subject to rules and regulation of Central Government in that behalf;
- xix) to lay down, for teachers, service conditions including code of conduct, workload, norms of performance appraisal and such other instructions or direction as per the norms of the University Grants Commission and Central Council from time to time;
- xx) to undertake development programmes in Health Sciences, Science and Technology, Sports, Liberal Education, Performing Arts, etc. research consultancy based projects and training programmes for outside agencies by charging fees so as to generate resource;
- xxi) to provide for instructions and training in such branches of modern medicine and allied sciences, as may be considered suitable and to make provision for research and for the advancement and dissemination of knowledge in Health Sciences and other branches of knowledge;
- xxii) to institute and award degrees, diplomas, certificates and other academic distinctions for persons who shall have pursued approved courses of study in the Institution Deemed to be University and shall have passed the prescribed examination of the

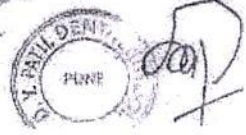

Institution Deemed to be University and shall have carried out research satisfactorily under condition as may be prescribed;

- xxiii) to develop, upgrade and start departments or schools in Medical, Sciences and Technology, Management, Bio-Technology, Bio-Informatics, Liberal Education and specialties and super specialties as may be required and to provide instruction for such courses of study as it may determine;
- xxiv) to confer honorary degree or other distinctions under conditions as may be prescribed;
- xxv) to prescribe conditions under which the award of any degree, title, diploma and other academic distinction may be withheld or withdrawn as the case may be;

- xxix) to undertake publication of research work pertaining to the Health Sciences, Science and Technology, Humanity, Social Sciences, Performing Arts, Sports, etc;
- xxx) to establish and maintain Research Station and Museum;
- xxxi) to create research posts and appoint suitable persons to such posts;
- xxxii) to establish suitable residential accommodation to the employees to the extent possible;
- xxxiii) to make special provisions for the higher education to the students belonging to socially disadvantaged class and women;
- xxxiv) to appoint either on contract, or otherwise, visiting professors, emeritus professors, consultants, fellows, scholars, artists, course writers, adjunct teachers and such other persons who may contribute to the advancement of the object of the Institution Deemed to be University;

  - xxxvi) to make the provision for constituent colleges such as Engineering and Technology, Architecture, Pharmacy, Health Sciences, Management, Bio-technology, Bio-Informatics, Sports, Performing Arts and such other institutions which it deem fit;
  - xxxvii) to provide for establishment of sub-campus, off campus centers within country and outside the country;
  - xxxviii) to do such other acts or make such other provisions as may be deemed necessary or desirable to further the objects of the Institution Deemed to be University
  - xxxix) to comply with and carry out any directions issued by the University Grants Commission, Central Government or Central Council, from time to time, with reference to above powers and duties and responsibilities.
  - xi) To invest the funds of the Institution of Deemed to be University in modes specified under the provisions of Sec.13 (1) (d) read with Sec.11 (5) of the IT Act, 1961 and as amended from time to time.
  - xii) The accounts of the Institution Deemed to be University shall be maintained properly and shall be duly audited by the Chartered Accountant every year. The financial year of the university shall be closed by 31st March.  
The university shall not amend the MoA without the prior approval of Commissioner of income Tax and the university shall not amend the MoA which may prove to be repugnant to the provisions of Sec. 2(15), (11), (12), (13) and 80 G of Income Tax Act 1961 and as amended from time to time.

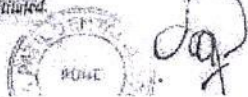

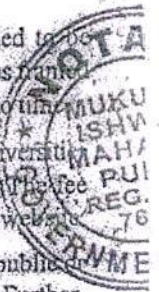

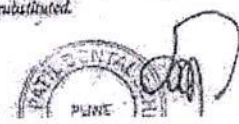
**3.A.07- ADMISSIONS AND FEES STRUCTURE**

- 7.1 Admission of students to all deemed to be universities, public or private, shall be made strictly on merit based on an All India examination as prescribed by the Regulations and in consistence with the national policy in this behalf, from time to time.
- 7.2 Admission of Non-Resident Indians (NRI) / Persons of Indian Origin (PIO) / Foreign Students to institutions deemed to be universities shall be governed by the guidelines / Regulations framed by the Commission in this behalf from time to time.
- 7.3 The Institution Deemed to be University shall preserve the records of admission at least for five years.
- 7.4 The fee structure for various programmes of study in the deemed to be universities shall also be fixed in accordance with the Fee Regulations framed by the Government or by the Commission in this behalf from time to time.
- 7.5 The level of the fees charged for the courses offered in deemed to be universities shall have a reasonable relation to the cost of running the course. The fee structure shall be displayed in the prospectus and on the institution's website.
- 7.6 Every institution declared as a Institution Deemed to be University, public or private, shall ensure that there is no commercialization of education. Further, every such institution shall provide for equity and access to all deserving students.
- 7.7 On being declared an Institution Deemed to be University under the Act, an institution shall admit students to its approved academic programmes, under its enrolment, only from the academic session that follows the notification issued by the Central Government. Enrolment of students to the institution, for any reason whatsoever, in anticipation of the declaration as an Institution Deemed to be University or inclusion of the institution under the ambit of an Institution Deemed to be University, shall render the application invalid. The students already on the rolls of the institutions prior to the date of application for declaration as an Institution Deemed to be University or its inclusion

**A.09- INCOME AND PROPERTY OF THE INSTITUTION DEEMED TO BE UNIVERSITY NOT TO BE PAID OR TRANSFERRED BY WAY OF PROFIT**

No portion of the income and property of the Institution Deemed to be University shall be paid or transferred directly or indirectly by way of profit to the persons, who at any time or have been member of the Institution Deemed to be University or to any of them, provided that, nothing herein contained shall prevent the payment in good faith or remuneration to any member thereof or other person in return for any services rendered to the Institution Deemed to be University or for traveling, halting and other similar charges.

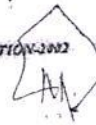

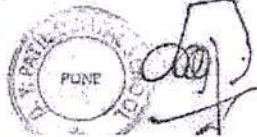

- 3.05 "Constituent Institution" means an institution operating under the administrative, academic and financial control of the sponsoring body and declared as such under the Notification.

- 3.10 "Institution Deemed to be University" means an institution for higher education declared, on the recommendation of the Commission, by the Central Government and Section 3 of the Act.
- 3.11 "Processing Fee" means the charges that have to be paid by the applicant institution to the Commission along with the application for processing such application. The Commission shall take into account the expenditure to be incurred by the Commission for processing an application that shall include onsite visits of Expert Committees of the Commission. The Commission shall prescribe the processing fee and revise it from time to time.
- 3.12 "Notification" means a notification issued by the Central Government in the Official Gazette declaring an institution for higher education, as an Institution Deemed to be University u/s 3 of the Act. "Sponsoring body" means a body being a charitable or a not-for-profit Society or Trust making an application for declaring an institution under its administrative, academic and financial control as a Institution Deemed to be University.
- 3.13 "Statutory body" means a body constituted under any law for the time being in force for determining or maintaining standards of quality in the relevant areas of higher education and bodies known as All India Council for Technical Education (AICTE), Medical Council

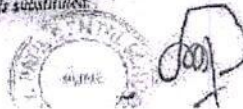

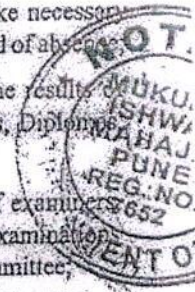

- (i) The Board of Management shall meet at least four times a year. Not less than 15 days' notice shall be given of a meeting of the Board of Management. Eight (8) members shall make the quorum for a Board of Management meeting.

**PR.11 PLANNING & MONITORING BOARD:**

- 11.1 The Planning & Monitoring Board shall be the principal Planning Body of the Institution Deemed to be University and shall be responsible for the monitoring of the development programmes of the Institution Deemed to be University.

- iii) Where an inspection or inquiry has been caused to be made by the Commission, the Institution Deemed to be University shall be entitled to appoint a representative

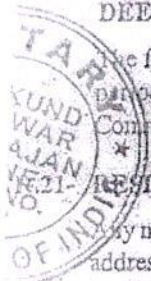

- vi) Where the Board of Management does not, within a reasonable time, take any action to the satisfaction of the Commission, the Commission may, after giving due consideration to the explanation furnished or representation made by the Board of Management to it, issue such directions as it may think fit and the Board of Management shall comply with such directions.

**R.20 REVIEW OF THE ACADEMIC ACTIVITIES OF THE INSTITUTION DEEMED TO BE UNIVERSITY**



The functioning of the Institution Deemed to be University may be reviewed after a period of every 5 year or earlier, if necessary, by a Committee appointed by the Commission.

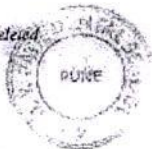

**\*R.23-VALIDATION OF CERTAIN ACTIONS, DECISIONS**

No action or proceedings of any authority or anybody or any committee of the Institution Deemed to be University shall be invalid merely by reason of any vacancy therein.

**\*R.24-DISQUALIFICATION**

- (a) A person shall be disqualified for being chosen as and for being a member of any of the authorities of the Institution Deemed to be University:
  - i) if he/she is of unsound mind
  - ii) if he/she is an un-discharged insolvent
  - iii) if he/she has been convicted by a court of law of an offence involving moral turpitude.
- (b) If any question arises as to whether a person is or has been subjected to any disqualifications mentioned above, the question shall be referred for decision to the Chancellor and his decision shall be final.

**R.25- FILLING OF CASUAL VACANCIES**

Casual vacancies among the members (other than ex-officio members) of any Authority or any other Committee of the Institution Deemed to be University shall be filled as soon as it may be convenient by the person or the authority who appointed or co-opted the member whose place has become vacant and the person appointed or co-opted to a casual vacancy shall be member of such Authority or Committee for the residual term for which the person whose place he fills would have been a member.

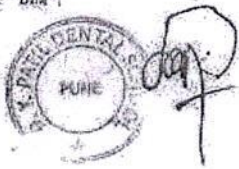

**R.37-DISTANCE EDUCATION:**

No Institution Deemed to be University, so declared by the Central Government subsequent to these Regulations, shall be allowed to conduct courses in the Distance mode. Also, such institutions declared as such, prior to these Regulations, shall not be allowed to conduct courses in the Distance mode from any of its off-Campus Centre / off-shore Campus approved subsequent to these Regulations.

**R.38-USE OF THE WORD 'INSTITUTE'**

An Institution Deemed to be University shall not use the word "Institute" suffixed to its name but may mention the words "Deemed to be University" within parenthesis suffixed thereto.

**R.39-PROHIBITION OF USE OF CERTAIN WORDS IN NOMENCLATURE**

Educational institutions established by the Central Government alone may prefix the words, "Indian / National Institute" (either in English or in vernacular) with their respective names.

**R.40-CONSEQUENCES OF VIOLATION OF REGULATIONS**

The Central Government / Commission shall have the right to cause an inspection of the Institution Deemed to be University, its buildings, laboratories, its examinations, teaching and other work conducted or done by the Institution Deemed to be University, and to cause an enquiry to be made, if considered necessary by the Central Government / UGC, in respect of any matter of the Institution Deemed to be University.

The Central Government / Commission shall have the right to cause an inspection of the Institution Deemed to be University, its buildings, laboratories, its examinations, teaching and other work conducted or done by the Institution Deemed to be University, and to cause an enquiry to be made, if considered necessary by the Central Government / UGC, in respect of any matter of the Institution Deemed to be University.

In the event of such withdrawal of the declaration, the entire movable and immovable properties of the Institution Deemed to be University shall stand forfeited to the Commission. For first violation, the withdrawal may be restricted to one academic session which can be extended up to five academic sessions for repeated violations. However, for serious and deliberate violation, the status of Deemed to be University shall be withdrawn permanently.

40.3 In the event of the withdrawal of the Deemed University status, action shall be simultaneously initiated to protect the interests of the students according to such precedents and practices as applicable or determined for the specific situation.

40.4 If an Institution Deemed to be University wishes to withdraw itself or its constituents from the status of 'Institution Deemed to be University'; it may do so with the prior permission of the Central Government. Such withdrawal shall take effect only after the last batch of students then enrolled, passes out of the Institution Deemed to be University.

**\*R.41. MAINTENANCE OF STANDARDS**

An Institution Deemed to be University shall maintain standards, higher than the minimum, of instruction, academic and physical infrastructure, qualifications of teachers, etc. as prescribed for college level institutions by the Commission or by the Statutory/Regulatory body concerned, such as All India Council for Technical Education (AICTE), Medical Council of India (MCI), Dental Council of India (DCI), National Council for Teachers Education (NCTE), Bar Council of India (BCI), Indian Nursing Council (INC), etc. and shall obtain their approval for running various programmes of study, wherever applicable. This shall be periodically monitored by the duly constituted Committee (s) of the Commission.

**\*R.42. JOINT PROGRAMMES**

42.1 An Institution Deemed to be University may conduct joint academic programmes with other Universities / institutions deemed to be universities in India or abroad with the prior approval of the Commission. The proposed joint programme(s) shall conform to the Acts and Rules of the Commission that shall apply to such programmes from time to time.

42.2 There shall be sufficient safeguards so as to protect the interests of students enrolled in such programmes.

42.3 The joint programmes shall be subjected to mandatory assessment and accreditation

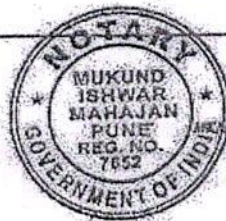
